Course Description

This course will help to answer the who, what, why, and how of pastoral ministry. Who are we as pastors? What do we do? Why do we minister? And how are we to conduct ourselves and lead the church in the twenty-first century? Roughly half of the lectures will focus on the biblical and theological underpinnings for pastoral ministry, while the other half will show how these principles are played out in the nitty-gritty details of church life. In other words, the class is part theological reflection, part personal soul work, and part how-to survival guide.

Course Requirements

These requirements are different than those in the normal semester long version of the class (should you be familiar with the regular course from other students).

- 1. Reflection Papers (30%) You will write a reflection paper (400-450 words each) on the following books: *Memoirs of an Ordinary Pastor* (Carson) is **due June 15**, *Shepherds after My Own Heart* (Laniak) is **due June 22**, *The Art of Pastoring* (Hansen) is **due June 29**.
- 2. Memorization (10%) Students will memorize <u>1 Timothy 3</u>. You may choose a reputable English translation to memorize. You will be called upon to write out the chapter on the **last day of class, June 29.** Start working on these 16 verses once you register.
- 3. Required Reading (25%) Reading is an important part of the class. Students are expected to read all the assigned material *with reasonable care*. This means skimming does not count. These books were chosen with your pastoral identity and effectiveness in mind, so read them well, digest them, and enjoy them! All the required reading is **due July 25**. Send me an email indicating the percentage of reading completed.
- 4. Final Paper (25%) Students will write a final paper (2000-2500 words). This paper should describe and evaluate two persons—one that you know personally and one that you know from history—whose ministries are worth emulating and provide a model for your own. You may have to do some basic research for the historical model, but I am not looking for

an academic paper. Please interact with Scripture and with what you have learned from the class. Do NOT use material or research from other another course. As always, give proper attribution and use footnotes if necessary. The paper is **due July 25**.

5. Student Interactions (10%) – Complete required interactions as per Canvas instructions. Due by the end of class instruction on **June 29**.
