ST6610 – Christian Cultural and Social Theory RTS New York City – Winter 2023 Chris Watkin 2 credit hours

Course description

Through an analysis of late modernity through Genesis to Revelation, we will explore the Biblical resources for developing a distinctly Christian cultural theory. Alternative social theories will be critiqued with a view to showing how the Bible supplies resources for a cultural theory at once more critical and hopeful than secular alternatives.

Course learning outcomes

- (1) To explore how the biblical narrative provides a framework for engaging with and critiquing late modern culture
- (2) To bring this framework to bear on specific aspects of late modern thinking and living
- (3) To identify how this framework informs a distinctively biblical cultural and social theory

Attendance expectations

Attendance will be taken for each morning/afternoon session. Attendance is expected, and absences that are unexcused as per RTS guidelines will incur a penalty. For all absences, excused and unexcused, extra work will be assigned: 1 hour of extra reading with a written report for every hour or part hour of class missed.

Course requirements (how grade will be determined)

 Attendance and active participation. Attendance throughout at all six sessions (morning and afternoon) of the course, and active engagement in group and whole-class discussions. (10% of grade)

- 2. Reading. Submit a reading report for each morning and afternoon session, indicating the % completed for each reading. (20% of grade)
- 3. Exam. Canvas-based open-book exam. Select three topics from a list of six on the exam, and write a short essay in response to each of the three topics you choose. Time allowed: three hours. (30% of grade)
- 4. Research paper with ministry application. In light of what you learned in this course, bring one or more specific ideas from the required reading to bear on one question, issue or problem in contemporary culture, explaining how the Bible brings a distinctive perspective to bear on that issue or problem. In the final section of your paper, reflect upon how your thoughts about the question, issue or problem might be packaged in a way that would help train lay Christians to think biblically about the whole of life. 3000-4000 words. (40% of grade)

All submitted assessment items are due three weeks after the end of the course: Monday 13 February 2023, 9am.

Research paper guidelines

- Your paper should take the form of an argument. I.e. you should aim to explain and defend a particular interpretation of culture through a biblical lens. Do not simply present different options. You may wish to deal with alternative interpretations as you make the case for your own, but your aim is to persuade your reader of the helpfulness and insight of your approach.
- Your first paragraph should clearly state for the reader 1) what aspect of culture you will discuss,
 2) what biblical tool(s) and/or approach(es) you will take, and 3) what light you think your tools/approach shed on the aspect of culture you have chosen.
- You are expected to engage with relevant secondary material as you make your case, including but not restricted to items from the required reading.
- All ideas that are not your own must be adequately referenced. Please use the <u>"notes and bibliography" Chicago referencing system</u>.
- A list of references should be added at the end of the paper, under the title "References".
- Footnotes are included in your word count, but the list of references is not included in your word count.
- Given the broad range of the word count for this paper (3000-4000 words), there is no leniency with the upper and lower limit: penalties apply for writing too little or writing too much.
