## Religious Freedom Essentials for Ministry Leaders (1 credit)

Thursday, April 4, 6:30 p.m. – 9:30 p.m.; Friday, April 5, 6:30 p.m. – 9:30 p.m. Saturday, April 6, 9 a.m. – 5 p.m.

This course will survey the legal principles that safeguard religious freedom, including their theological, philosophical, and historical underpinnings, as well as new developments affecting churches and ministries. It is designed to equip ministry leaders committed to maintaining a biblical confession with a greater understanding of the policy and legal environment so they can navigate shifting circumstances with wisdom and sound judgment.

#### **Classes**

- Class 1: Introduction: theology and history of religious freedom; overview of U.S. legal framework (constitutional and statutory) protecting religious freedom.
- Class 2: Employment law issues in ministry; freedom of association and the autonomy of religious institution; freedom of religious expression.
- Class 3: Government funding and religious organizations; government regulation of places of worship and other religious institutions; tax issues involving religious expression and other ministry functions; special issues involving religious institutions in litigation; current conflicts in the courts between religious liberty and other societal values.
