COURSE DESCRIPTION

This course is an exploration of medical issues connected to biblical counseling. Special focus will be given to developing a basic framework for medical care in counseling. Additionally, counseling individuals with various specific health afflictions will be considered.

COURSE OBJECTIVES

By studying the materials presented in this course, listening to the lectures, and completing the assignments and assigned projects, the student will be able to:

- A. Articulate a biblically developed, theologically informed understanding of biblical counseling theory as related to physiology and medical matters
- B. Apply this theory by outlining techniques for counseling

Percentage of the book skimmed

This is not a requirement, but for the sake of completing assignments with thoroughness, thoughtfulness, and not having a really miserable life for a month, please start early.

ASSIGNMENTS AND ASSESSMENTS

This course is entirely electronic in its submitting of assignments. Each assignment will be uploaded to Canvas in the appropriate portal. If you have any questions regarding the use of Canvas, please reach out to the class TA.

1. Reading Reports

Students are to turn in a report stating the percentage of each book or pamphlet read by the due date. No summaries are required on this page.

2. Reading Reflection

Students are to turn in a four-page reading reflection for the following book. *This reflection is not a book report*. Instead of summarizing material, you are to interact with the book through the questions noted below. Students are to answer each question thoroughly, though the amount of space dedicated to each question within the four-page limit is discretionary.

The Christian Counselor's Medical Desk Reference, Hodges (4 pp.)

- 1. Chapter 1 There is a framework given for dealing with DSM labels. Please use it to assess one of the DSM5 labels with which you are familiar.
- 2. Chapter 2 How is the doctrine of the sufficiency of scripture described in this chapter? How is it applied to Biblical counseling? Please interact with the concept. How does medical knowledge fit in this framework. Do you agree or disagree? Please support your thinking.
- 3. Chapter 12 How is OCD presented in this chapter? As a medical or spiritual problem or both? How do you see this issue? Please support your viewpoint.
- 4. Chapter 13 How does this chapter present Schizophrenia? How do you view this problem, spiritual or medical? Please support your answer biblically and medically.

3. Research Paper

Students will select a topic related to biblical counseling and physiology or medical issues and write a 10-12 page research paper (double spaced). This paper must advance a thesis and make a case for that thesis through research-backed argumentation. Students are highly recommended to read the materials in the research paper folder on Canvas for aid in formulating and arguing a thesis. Papers are to have a minimum of 10 academic sources (books, journal articles, etc).

4. Class Attendance and Participation

Come to class, pay attention, and engage. Simple enough!

RTS Charlotte Classroom Technology Usage

RTS Charlotte recognizes how essential it is for students to have reliable, campus-wide access to the internet. For that reason, we have made Wi-Fi available for our student body, not only in the library and student lounges, but also in the classrooms. We know that students need to use the internet to download class materials, access files on the Cloud, and locate other important information. However, we also recognize that internet access in the classroom provides opportunity for abuse and misuse. Some students have unfortunately used their internet access to engage in many activities that distract them from the classroom lectures (e.g., surfing the web, checking sports scores, playing games). Not only does such activity hamper a student's own seminary education, but it distracts other students who can easily view the screens of nearby students.
